

Rule changes for 2015

Page 152 ISC REGION DEFINITIONS:

A motion was made that Canada be divided into three Regions as follows:

Canada West: Saskatchewan, Alberta, British Colombia, Yukon Territories & North West Territories.

Canada East: Manitoba, Ontario, Quebec & Nunavut.

Atlantic Canada: New Brunswick, Prince Edward Island, Nova Scotia, Newfoundland & Labrador. **Motion Passed**

A motion was made that the US East Region be revised by changing the Caribbean Islands and Dominican Republic to International. **Motion Passed**

Due to the ISF Championships and the Pan Am Games, international players participating in these events would find it difficult to play in invitational tournaments or qualifiers for the months of June and July, therefore:

Page 155 ELIGIBILITY RULES:

9. Rule states: Each ISC team is required to participate in invitational (or Qualifier) tournaments in both June and July.

A motion was made to suspend Eligibility rule 9 on page 155 of the guide for the year of 2015. **Motion Passed**

Page 156 ISC WORLD TOURNAMENT AND AFFILIATED TOURNAMENTS:

Rule states: The entry fee for all teams shall be \$450(US) for the ISC World Tournament and all affiliated tournaments. All entry fees are to be paid by July 10.

A motion was made that the Dead line for team entry fees be moved to July 1st. **Motion Passed**

Page 158 OOR Players Fees - paragraph 5

Rule states: Approved out-of-region players on all ISC teams must play in at least one approved ISC Qualifying event or in invitational tournaments in both June and July, with their current year's team, to be eligible for World Tournament play.

A motion was made that the playing rule on page 158 of the 2014 ISC Guide Book, (b) Out of Region Players Fees, Paragraph 5 be suspended for 2015 due to a conflict with the Pan Am Games. **Motion Passed**

Page 158 c) OOR PITCHERS:

Rule states: Team rosters for all ISC play shall be restricted to the same two (2) out-of-region pitchers for the entire season. Pitcher is defined as any player on an 18-man roster who pitches in any ISC competition. The two (2) pitchers for ISC Championship play are deemed to be the first two (2) that pitch in ISC Championship play in any bracket.

A motion was made that team rosters for ISC Championship play will be restricted to three pitchers, these three will be the first three that pitch in the ISC WT. Of these three pitchers, the limit is two OOR and one PRAWN. **Motion Passed**

Page 159 PRAWN Extension

Rule states: A PRAWN that plays in more than one tournament for a team prior to the World Tournament, but is not included on that team's roster for the ISC World Tournament, and does not participate for any other team in the World Tournament, will have his PRAWN status extended for one additional year.

A motion was made that PRAWN extension (listed under PRAWN restrictions) be eliminated from the ISC Rule Book. **Motion Passed**
